## Context

Bryn Tirion Hall School is located in a large country house in a rural area between Wrexham and Flintshire. The school grounds are extensive and provide pupils with a peaceful outdoor space.

The school has places for 24 pupils, with 10 residential places available at the children's home. There are currently 23 pupils on the school roll with an age range between 7 and 17 years. Ten of these live in the children's home. Thirteen pupils have statements of special educational needs.

The school has recently completed a restructure of the senior management team and increased its staffing to include a pastoral support manager.

# **Main findings**

# **Strengths**

The senior team work very well to evaluate practice and resources to inform improvement planning

Communication between the children's home and school is positive and is making a difference to pupils' behaviour

The school consults with pupils and parents very effectively to influence policy and practice

The school is carrying out a number of useful initiatives to improve its understanding of the needs of all pupils

Pupils at the school behave well in class and are engaged in their learning

### Areas for development

Planning for the smooth progression of pupils to local 14-19 provision including further education is underdeveloped

# Recommendations

#### The school should:

R1 Ensure that there are effective partnerships in place that allow pupils to transfer smoothly to local schools and further education, where this is appropriate

# Progress in addressing recommendations from previous note of visit or inspection report

# Recommendation 1: Address the requirements of the Independent School Standards (Wales) Regulations 2003

This recommendation has been fully addressed.

The school has revised the safeguarding policy and it now meets requirements.

### Recommendation 2: Make sure that relevant policies link together

This recommendation has been fully addressed.

All policies now show links to other school policies and national guidance documents.

# Recommendation 3: Amend the behaviour policy to reflect the practices at the school including the system for rewards and sanctions

This recommendation has been fully addressed.

The school has amended its behaviour policy. Pupil rewards are now clearly defined and are appropriate to the pupils. The process for allocating rewards has been adopted by all members of staff. The policy also sets out clearly the school's processes for imposing sanctions.

# Recommendation 4: Analyse the trends and patterns of pupils' behaviour to evaluate the impact of school strategies

This recommendation has been fully addressed.

The school has appointed a pastoral manager to take responsibility for analysing patterns of behaviour to identify trends in challenging incidents. This has resulted in a reduction in the number of interventions required at the school.
