Procurement system: (I assume you mean how we raise purchase orders rather than selecting suppliers?)

- •Who is your current provider? Advanced Business Software Solutions
- •When does the contract expire, and do you have extension options? It is an annual renewal
- •What is the value of the contract? Under £30,000 per annum
- •What is your budget? Under £30,000 per annum •When did the contract start? 2009 Invoicing:
- •What is your current invoice process? We have very little income as were a Government organisation. Any income we invoice for is done through the sales day book.
- •Do you have an electronic invoicing system in place? Yes Advanced Business Software Solutions
- •If so, when does this expire and is there extension options? As above
- •Who is the current provider? As above
- •What is the value of the contract? As above
- •What is your annual paper usage? We don't cost our paper usage; it is all part of the stationery budget and expenditure.
