Thank you again for your email, in which you formally request information in regards to learning and development spend.

When dealing with requests for information made under the Freedom of Information Act 2000 (the 'Act'), Estyn's obligations include:-

1. Confirming or denying whether it holds information of the description specified in the request; and

2. Communicating the information requested to the applicant.

There are a number of exemptions under the Act that impact these obligations. Estyn is required to consider whether an exemption applies in the context of the information being released into the public domain, not just in the context of the information being released to the particular applicant that has requested the information.

If Estyn releases information in response to a Freedom of Information request, this is essentially a decision that the information can be released in response to any similar request from any member of the public.

In response to your request, I attach a document responding to the questions you have raised. I hope that this response is helpful.

If however you are not satisfied with the decision Estyn has taken regarding your request for information, you are entitled to request that we review the matter. Your request for a review should be addressed to the Feedback and Complaints Manager, and received no later than 20 working days after the date of this communication.

If you are still not satisfied, you also have a right to complain to the Information Commissioner through their website:

Our training budget for 2020-2021 is £40k. We do not have separate budgets for internal or external training or for Civil Service learning spend. This budget is flexible and can be allocated to any training spend.

  - For example, are you planning greater emphasis on Leadership & Management courses or training delivered through digital/online courses?

We have not undertaken any detailed analysis of how our training needs have shifted this year. We have provided access to a number of tools and learning to support individual's wellbeing and mental health and are currently placing a greater emphasis on delivering training through digital/online courses where possible due to the COVID-19 pandemic. We will be developing a learning and development strategy over the next six months and this will most likely include leadership and management development.

On 30 September 2020, Estyn had 115 civil service employees.
