## **FOI request**

Thank you again for your email, in which you formally request information in regards to school inspections.

When dealing with requests for information made under the Freedom of Information Act 2000 (the 'Act'), Estyn's obligations include:-

1. Confirming or denying whether it holds information of the description specified in the request; and

2. Communicating the information requested to the applicant.

There are a number of exemptions under the Act that impact these obligations. Estyn is required to consider whether an exemption applies in the context of the information being released into the public domain, not just in the context of the information being released to the particular applicant that has requested the information.

If Estyn releases information in response to a Freedom of Information request, this is essentially a decision that the information can be released in response to any similar request from any member of the public.

In response to your request, I confirm the following:

## <u>1. How many schools in Wales are currently rated as: Excellent; Good; Adequate;</u> <u>Unsatisfactory?</u>

We do not provide an overall grade for schools following inspection. All but one of the schools not inspected in more than seven years were inspected during the 2010-2016 cycle and are due to be inspected within the current cycle. Ysgol Bro Alun is the exception, since it opened in 2013 and was not inspected in the previous cycle. It was scheduled for Spring 2020 and cancelled due to COVID. One more school (Ysgol y Ddraig) also opened in the previous cycle (2015) and hasn't been inspected yet, but is within the parameters specified in paragraph 13 of the document above. Also please note that schools do not have core inspections while in follow-up (although they have regular monitoring visits), so this might increase the interval between core inspections.
