About Oaklea Grange

Oaklea Grange entered the register for independent schools in Wales in January 2023. The school is part of Young Foundations limited, a group which currently owns schools and children's homes in England and Scotland. The group is part of the portfolio of MRA UK investments limited.

Oaklea Grange School is the company's first school in Wales. The school can educate a maximum of eight pupils between the ages of 11 and 18 years. There are currently five pupils on the school's roll. All pupils are resident in the on-site children's home.

The school admits pupils with difficulties relating to their: social emotional and mental health; trauma and attachment and, behaviour.

The school is set in a rural location. The accommodation is across two floors and comprises three classrooms, an office and a garden.

The headteacher has been in post since the school was established.

Main findings

Strengths

Pupils are fully engaged in their learning often after having experienced significant gaps in their education.

Pupils are welcoming to visitors and engage positively with staff. They concentrate well when working independently, for example when considering how games help toddlers develop their fine and gross motor skills. They also work well with their peers in small groups.

Pupils are developing their confidence. They clearly articulate their opinions, for example when debating the relevance of the main themes of a 'Christmas Carol' in today's society.

Pupils hold positions of responsibility within the school including the mental health advocate, reading champion and the health and safety officer. Pupils value these authentic leadership opportunities.

All staff are highly effective at meeting the well-being and learning needs of pupils. They have strong professional working relationships, leading to a calm and nurturing learning environment.

There is a strong culture of safeguarding and pupils feel happy and safe.

The school provides a highly bespoke curriculum for each pupil. Teachers plan interesting lessons that develop pupils' skills and understanding of new concepts, for example making sushi when learning about the culture of Japan. They use stimulating resources and build on pupils' prior experiences effectively.

The school provides relevant and interesting opportunities for pupils to engage with the local community. For example, the school choir performs in the local village and pupils contribute to the local food bank.

The headteacher is passionate about the successful development of the school and has high expectations of staff and pupils alike. She has a strong vision for the school, which is well understood and implemented by the whole school community.

The school meets all of the Independent School Standards (Wales) Regulations 2003 inspected during this visit.

Recommended areas for action

- Embed the effective practice seen during this visit
- Ensure consistency in the quality of written feedback
